COUNTRY CLUB POOL GUIDELINES

The Villages Country Club Pools are for the exclusive use of Villages Country Club Priority Members and their guest(s). All Country Club Pools are family pools.

If you wish a more quiet pool setting, you may want to use one of The Villages adult pools instead.

IN GENERAL

- Country club pool ambassadors are not lifeguards. Swim at your own risk.
- Please follow all posted pool hours, rules and regulations for your safety as well as for the safety of others.
- Outside food, beverages and personal coolers are not allowed in the pool or surrounding area.
- Pets are not allowed in the pool area.
- Smoking is permitted in designated areas outside the pool.
- For emergencies please call 911. All pools have courtesy phones.
- If a staff member is present, please check in with them. Have your Villages ID with you at all times.
- Guests must have appropriate guest passes and a valid photo ID. In Area Guest Pass guests must be accompanied by the host resident and have their In Area Guest Pass and photo ID with them at all time.
- Guests under the age of 19 must be accompanied by an adult.
- Please be sure children 36 months of age and younger wear protective rubber pants in accordance with Florida health regulations.
- Pools will close during inclement weather.
- Waist Flotation Belts attached to the waist, diving mask, goggles, and infant/toddler flotation devices are the only items allowed in the pool.

EXERCISE: The use of exercise equipment, is permitted between the hours of 9:00 a.m. and 11:00 a.m.

- Please be courteous of other pool patrons
- Please be sure you are dry and wearing shoes and shirts when entering the country club buildings.
- Pool lounge chairs and tables are available on a first-come-first-serve basis and cannot be reserved. Kindly leave chairs and tables where you found them. If asked, please share your unused chairs with others.
- The Villages Jacuzzi pools are for people 16 years of age and older.

NON-RESIDENT – a person(s) residing outside The Villages.

GUEST – a non-resident living outside Lake, Marion or Sumter County or the child/grandchild of a RESIDENT who has applied for an In Area Guest Pass. The GUEST must obtain an appropriate GUEST pass.

INFORMATION ABOUT THE USE OF THE VILLAGES RECREATIONAL FACILITIES BY YOUR GUESTS

Guests of Villages' residents whose home address is outside Lake, Sumter and Marion counties are eligible to use selected Villages' resident amenity-supported recreational facilities.

A Villages Guest ID Card is required for all guests 1 year of age and older.

How to Obtain A Villages Guest ID Card: Stop by any Regional Recreation Center.

- Monday–Friday, 8:30am–5:00pm: Paradise, La Hacienda, Savannah, Mulberry Grove, Laurel Manor, Lake Miona, Colony Cottage, SeaBreeze, Eisenhower
- Saturday–Sunday, 8:00am–noon: Savannah, Lake Miona and Eisenhower
- Visit the District Customer Service Center: Monday–Friday, 8:00am–5:00pm

ONLINE: go to www.districtgov.org Please allow 3 (three) business days for processing all application requests other than in person. It is required that you show your current Villages Resident ID Card and complete a Guest ID Card application form. It is not necessary to bring your guest with you to obtain a Guest ID Card. **To ensure appropriate recreation privileges are assigned, please provide accurate information on the application.**

Be sure to tell your Guest: To always carry their valid photo ID showing their home address and Guest ID Card when they are using a Villages recreational facility, even when accompanied by a resident. If they are under 19 years of age, they must be accompanied by a Villages resident or a Villages guest 19 or over with a valid Guest ID Card and photo ID when they are using a Villages recreational facility.

Eligibility Requirements: A resident with a valid Resident ID Card can apply for a Guest ID Card. A qualified guest is defined as an individual whose current residence is outside Lake, Marion and Sumter counties. A resident who has a son, daughter, grandchild or great grandchild (and their spouses) who reside in Lake Marion or Sumter counties may apply for an In-Area Guest ID Card.

Guest ID Card Questions: If you have any questions regarding Guest ID Card services, please call the regional recreation center nearest you.

Please always carry your original Villages ID or Guest ID with a valid photo ID and follow all rules and regulations posted in recreation centers.

Inappropriate use and/or falsification of information on a Guest ID Card Application will result in loss of Guest privileges.
